c. i. The Trustees may open an account or accounts including deposit accounts with any one or more scheduled or nationalized banks in the name of the Trust. The bank account or accounts including deposit accounts shall be operated by the Managing Trustee or/and Chairperson.

m. The trustees shall be entitled to frame rules and regulations for the conduct of their activities and for the administration of the Trust and to alter, amend or vary such rules and regulations from time to time, as they may deem proper with a simple majority. However, no amendments in the Trust Deed shall be carried out without the prior approval of the Commissioner of Income Tax having Jurisdiction over the Trust.

n. The Board of Trustees shall have such other powers as may be found reasonable or necessary for the purpose of proper implementation of the Trust.

6. MEETING OF TRUSTEES

a. The trustees shall hold meeting at such intervals as they may decide. However, at least once in every year such annual meeting being known as "Annual General Meeting" shall be held. At every Annual General Meeting of the Trust, the Managing Trustee shall read before the meeting a report of the activities since the previous Annual General Meeting and lay before the Board of Trustees, the audited Income and Expenditure Account and the Balance sheet of the Trust for the previous accounting year.

a. Every property of the Trust, movable or immovable shall be kept in the name of the Trust and not in the individual name(s) of the Trustees.

b. Proper accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Trustees and the same shall be duly audited with all necessary vouchers at least once in every year by a Chartered Accountant or a firm of Chartered Accountants as may be appointed by the Trustees.
